

## DECLARATION OF CONSENT TO THE USE OF DATA FOR THE PROCESS OF GRANTING DOCTORAL RESEARCH SCHOLARSHIPS

I consent the ASSOCIATION FOR THE DEVELOPMENT OF THE ATLANTIC INTERNATIONAL RESEARCH CENTRE (AD AIR Centre) to proceed with collection, use, registration and processing of my personal data within the scope of my application to the selection process of granting doctoral research scholarships under the collaboration protocol signed between the AIR Centre and the Foundation for Science and Technology (FCT), in compliance with the European General Data Protection Regulation (GDPR) and the Privacy Policy, according to the Portuguese Law 58/2019, 2019/08 / 08.

I further declare that I have been informed of the following:

### 1. Which data is collected and processed

When submitting an application, the applicant must provide data strictly necessary for the respective process, in agreement with the Notice of the Call. The AD AIR Centre only requests relevant data for the purpose of candidate selection, excluding other type of data.

### 2. Purposes of collected data

Collected personal data are used and processed only for the purpose of conducting the evaluation process and candidate selection, within the scope of the call and in accordance with its rules. Collected personal data may be used anonymously, making it impossible to identify respective holders, in statistical studies.

### 3. Personal data processing controller

The AD AIR Centre legal person card holder nº. 514835117, at TERINOV - Science and Technology Park of Terceira Island - Canada de Belém s \n, Terra Chã, 9700-702 - Angra do Heroísmo, Azores, Portugal, is responsible for personal data processing.

### 4. Data Protection Officer (DPO)

The AD AIR Centre has appointed a DPO who provides information, when requested, on its obligations and issues regarding the processing and protection of personal data, in compliance with the applicable rules, constituting a contact between the data subject and the AD AIR Centre, as well as with the supervisory authority (National Data Protection Commission - CNPD), and who can be contacted via e-mail [gdpr@aircentre.org](mailto:gdpr@aircentre.org).

### 5. Treatment and storage of personal data

Collected personal data is stored in a database of exclusive access to those in charge of the AD AIR Centre scholarships, who participate in the evaluation and selection process. The statistical results, anonymity obtained from personal data, can be used outside the scope of the AD AIR Centre selection process.

### 6. Right of access to personal data

Authorizations to access personal data, granted to AD AIR Centre employees and jury members who participate in the evaluation and selection process, are registered and controlled through the segregation of profiles to access the computer system.

### 7. Rights of the personal data subject

As a rule, the data subject has the following rights in terms of personal data protection: right to be informed, right of access, right of rectification, right of erasure, right to restriction of processing, right of portability, right to object and the right not to be subject to automated decisions. The withdrawal of consent does not compromise the lawfulness of the treatment carried out based on the consent previously given.

#### 8. Procedure for the Exercise of the Rights

To exercise their rights, the data subject must contact the AD AIR Centre, via email [gdpr@aircentre.org](mailto:gdpr@aircentre.org) or by letter: to the attention of the DPO, Estrada das Laranjeiras, 205, 1649-018 Lisbon - Portugal. The exercise of rights is free, unless it is a manifestly unfounded or excessive or unreasonably reiterated request, in which case a reasonable fee may be charged taking into account the costs.

The response to requests must be provided without undue delay and within one month of receiving the request, unless it is a particularly complex request or occurs in exceptional circumstances. That period may be extended up to two months, when necessary, taking into account the complexity of the application and the number of applications.

As part of your request, you may be asked to provide proof of your identity in order to ensure that the sharing of personal data is only done with the respective data subject. If you wish, you can also file a complaint with the National Data Protection Commission (CNPD).

#### 9. Retention of your personal data

Your personal data collected by the AD AIR Centre are stored for the period necessary to fulfill the purposes set out in point 2 of this declaration. For the proper purposes, I declare that the information I provide is correct and true, and I authorize the AD AIR Centre to collect, use, register and process it, within the scope of the evaluation and selection process for the award of research scholarships for doctoral studies.

I further declare that I authorize the processing of data and accept access to it by the AD AIR Centre employees and jury members, who carry out all activities necessary for the purposes related to the evaluation and selection process.
